Kindly refer to this Office letter of even no. dated 08/09/2016, vide which it was requested to issue Notifications for holding Limited Internal Competition Examination (LICE) for promotion to the grade of JTO (T) for the vacancy year 2015-16 in BSNL.

2. In this regard, vide para 3 of the aforesaid letter, the Circles were requested to calculate the vacancies as under :-
