

This is regarding collection of Service books of CDA/IDA Pensioners from MTNL/BSNL by the Pr.CCA/CCA offices as decided vide this HQ OM No. 7-77/2013/TA-1/6092-6125 dated 21-11-2017. The matter was also discussed during the CCAs conference held at Sri Nagar(J&K) from 03-05-2018 to 04-05-2018 and it was decided anonymously to complete the task of collection of all the service books of IDA/CDA Pensioners latest by 30-06-2018 at the respective office of Pr.CCA /CCA from the BSNL/MTNL offices.

But despite issue of reminders vide Letter No. 7-77/2014/TA-1/6424-55 dated 08-12-2017, reminder letter No.7-77/2013/TA-1/648-672 dated 23-02-2018, Letter No.7-23/2018/TA-1/CCA Conference/1975-1999 dated 11-05-2018, e- mail reminder dated 01-06-2018 & 27-06-2018 on the subject cited above the task has not been completed and status report on the subject is still awaited from many offices.

It is therefore, reiterated to co-ordinate immediately with all the field offices of BSNL/MTNL to collect the service books of IDA/CDA Pensioners as soon as possible and submit the status report to this HQ. Adequate arrangements also need be made for indexing and safe record keeping for the service books. This should be given top priority.
