Points submitted by the Unions/ Associations for discussion:

- 1. Early roll out of PAN India 4G and testing of 5G. Budgetary financial support to BSNL for compensating loss due to delay in launching of 4G through indigeneous technology.
- 2. Payment of the pending dues to BSNL, by the DoT, amounting to Rs. 39000 Crore.
- 3. No handing over of BSNL's mobile towers and optic fibre to the private, as envisaged in the National Monetisation Pipeline, as well as in the Government of India 's Budget.
- 4. Payment of pension contribution by BSNL, based on the actual basic pay, in accordance with the Government orders.
- 5. Speeding up of land monetisation process to off-set BSNL's debt.
- 6. Immediate settlement of 3rd Pay Revision for the Executives and Wage Revision of the Non-Executives.
- 7. Revised PO for E2 and E3 Standard Pay Scales for JTO/JAO and SDE/AO equivalent grades, in line with BSNL's recommendation dated 06.06.2016.
