In continuation of this office order of even number dated 11<sup>th</sup> July, 2014, the undersigned is directed to forward herewith a copy of the Ministry of Finance, Department of Expenditure OM No.21-1/2011-E.II(B) dated 5<sup>th</sup> August, 2013 on the above subject and to say that with endorsement of this order, the orthopaedically handicapped employees of BSNL with disability of upper extremities as per the conditions given in the DOE OM shall also be eligible for transport allowance at the rate as admissible to other handicapped employees (disability of lower extremities) mentioned in the Office Order dated 11.7.2014.

The other conditions of the office order dated 11.7.2014 shall remain unchanged.



**OFFICE MEMORANDUM**

**Subject:** Grant of Transport Allowance to Orthopaedically handicapped Central Government employees.

The undersigned is directed to refer to this Ministry's Office Memorandum No. 19029/1/78-E.IV(B) dated 3<sup>rd</sup> December, 1979, as amended from time to time and to say that the criteria for orthopaedically handicapped employees to draw Transport Allowance at double the normal rates has been reviewed in consultation with the Ministry of Health & Family Welfare. It has been decided that in partial modification of para 1 of Office Memorandum dated 3<sup>rd</sup> December, 1979 referred above, Double Transport Allowance shall be allowed to an orthopaedically Handicapped Government employee if he or she has a minimum of 40% permanent partial disability of either one or both upper limbs or one or both lower limbs **OR** 50% permanent partial disability of one or both upper limbs and one or both lower limbs combined. The other conditions of O.M. dated 3<sup>rd</sup> December, 1979 for granting Double Transport Allowance to orthopaedically handicapped Central Government employees shall remain unchanged.
