Subject: - Conducting of 8<sup>th</sup> Membership Verification.

Ref:- Our Union Letter No NU/CHQ/39 dated 15-04-2019.

Sir,

With reference to above cited letter it is reminding that the Recognisation period of the recognized unions is expiring by 18-05-2019.

As per the BSNL Recognisation Rules framed in 2012 para V the period of the Recognisation shall be three years only.( no were available period of the tenure is extendable).

So Management cannot extended the Tenure without modifying the rules if at all Management feels to modify the rules Management need to conduct the all Registered Unions meeting to collect the opinion of all Unions

It is also informed you sir as per the Ministry of Labour & Employment DMO L-52025(07)/2013-1R (Imp-I) 13-03-2013 (copy of letter enclosed) addressed to secretary DoT, New Delhi clearly mentioned that the Management may be asked to keep discussing the matters of day-to-day labour interests with the Recognised Union even after the expiry of its recognition period till fresh recognition is granted to any union, but should not indulge in finalization of major issues viz. revision of wages etc. (as per the above letter also the Management cannot extend the period of Recognisation at any cost).

Therefore our union demands to conduct the 8<sup>th</sup> Membership verification before 31<sup>st</sup> July 2019 other wise the present Recognised unions will take the advantage of the delay in conducting the verification this will shows the management indirectly supporting the recognised Unions.

If at all the Management unable to conduct the 8<sup>th</sup> Membership verification in time, management should allow Recognisation facilities to all registered Unions in BSNL till completion of 8<sup>th</sup> membership verification.
