SEA Section of Corporate Office, being the Cadre Controlling Authority for the cadre of JAO, is required to prepare the Circle-wise and Category-wise ~~list~~ list from the aforesaid Annexure, as per the vacancy position. SEA Section of BSNL Corporate Office, being the Cadre Controlling Authority, will also allot the Circle, vacancy year, seniority, promotions, postings etc. to the candidates declared successful on the basis of the finalised candidates by them, after verifying their service particulars and eligibility, as per the provisions of the Recruitment Rules issued vide letter No. 36-2/2001-SEA dated 31/08/2001 and subsequent amendments thereof.

3. As per the direction of Hon'ble High Court of Madras dated 15/07/2016 in WMP No. 20631/2016 in W.P. No. 24105/2016 filed by Shri M. Selvaraju & 10 Others, 11 posts of JAO pertaining to Tamil Nadu Telecom Circle have to be kept vacant.


4. The aforesaid list has been prepared considering only the Parent Circle of the candidate. In case of already inter-Circle transfer cases, such candidates may approach to the Cadre Controlling Authority for revision of posting on promotion.

5. The concerned Circles must verify the eligibility in respect of the candidates, against whose name '*' mark has been given in the list of candidates in **Annexure-A**.

6. The names of candidates, their Roll Nos., HRMS Nos. and Category have been shown as furnished by the Candidates concerned during Online Registration process/Online examination. All out efforts have been made to prepare the aforesaid list error free.
