

**Circular R&C-CFA No.214/17-18**

**Sub: - Withdrawal of Unlimited Free calling to any network on all Sundays from BSNL landline-Reg**

1. Kindly refer to R&C-CFA circular No.106/16-17 dated 10.08.2016 vide which unlimited free calling to any network on all Sunday from BSNL landline was allowed.
2. Now, The Competent Authority has decided as follows:
  - (a) **To withdraw unlimited Free calling from Landline/Combo/FTTH to all networks on all Sundays from 1<sup>st</sup> Feb 2018 on PAN India basis for all existing as well as new customers.**
  - (b) **Customers may be informed suitably in advance about above revision.**
  - (c) **The circles ensure to comply with all regulatory mechanism**
3. The above circular is applicable for all Landline/BB/Combo/FTTH customers.
4. The Circles should ensure to comply with all regulatory requirements.
5. **The above instructions shall be effective from 01-02-2018 in all the circles.**
