The under signed was appointed as Chief Returning Officer for conducting 9th Membership Verification through secret ballot for electing majority representative Union of Non-executive employees in BSNL vide letter No. BSNL/5-1/SR/2022 dated 22nd April, 2022.

2. The counting of votes was done on 14th October, 2022. On the basis of information received from all the Circles, consolidated information relating to votes polled and secured by all the 14 participating unions is furnished in the enclosed Annexure. It may be worthwhile to mention that by virtue of securing 15,311 votes, i.e. 48.62% of total votes, BSNLEU has emerged the largest Union whereas NFTE-BSNL is the second-largest Union by securing 11,201 votes, i.e. 35.57% of total votes in the Membership Verification.
