- (ii) Ensure that authentic revenue records and site-maps are readily available.
- (iii) Ensure that land/ buildings proposed for monetization are free from encumbrances.
- (iv) Ascertain permissible use of land and charge of land use, if required, and submit a separate report thereon Circle-wise.
- (V) Assess Circle rate as well as market value (as per Authorised Valuer) of proposed land / buildings.


