
Sub: Method of pay fixation in IDA pay scale in respect of absorbed officials of BSNL who were promoted after 1/10/2000 and opted IDA pay scales from the date of their promotion- reg-.

The issue of mechanism of fixation of pay in r/o absorbed employees of BSNL who have opted IDA pay scales w.e.f the date of their promotion which falls after 01.10.2000 is under consideration in this office in consultation with DOT.

2. DOT has sought following information;-

- i) Total number of employees/retirees effected and total expenditure thereon on aforesaid method of pay fixation.
- ii) Whether the pension contribution has been made by BSNL for the respective period? If so, the same may be intimated.
- iii) In case of Employees /pensioners, the arrear of pay and allowances paid from 01.10 2000 till date of promotion/retirement on IDA pattern has been recovered from them.
- iv) Total no. of Group "C" & "D" employees who have opted to retain Government pays scale till their promotion along with total financial implication.
- v) Total no. of Group "C" & "D" employees who have opted to retain Government pay scale till their retirement along with total financial implication.

3. It is requested to furnish the requisite information at the earliest to enable this office to transmit the same to DOT,

Sub : Method of pay fixation in IDA pay scale in respect of absorbed officials of BSNL who were promoted after 01.10.2000 and opted IDA pay scales from the date of their promotion –reg.

Please refer to this office letter of even no. dated 12.01.2014 on the subject cited above and to state that DOT has further sought the following information :-

“How was the pension of the absorbed employees, who opted for CDA pay scale and who retired from BSNL without any further promotion regulated on retirement?. Was he allowed pension based on CDA pay scale or IDA pay scale?. How his Dearness Relief who have never retired was regulated – whether under CDA rates or IDA rate?”.

2. In this regard, kindly intimate whether there is any case of absorbed employee in Group 'C' & 'D' cadre (Non-executive) who have never switched over to IDA pay scale and retired from BSNL with pension in CDA Pay.

3. This information may kindly be provided alongwith the information called for earlier vide this office letter dated 12.11.2014 at the earliest to enable this office to transmit the same to DOT.
