Sub.: Procurement of Ballot Boxes from Chief Electoral Officers of the States for holding 7th membership verification of non-executive employees' unions through secret ballot - regarding.

Ref.: Election Commission of India's letter no. 51/15/2015-EMS dated 19.04.2016.

The Election Commission of India has informed BSNL(copy enclosed), in response to this office letter of even number dated 4th April, 2016, to procure the required number of ballot boxes from the Chief Electoral Officers of the States/UTs concerned and has suitably informed its State Election Commissioners/Chief Electoral Officers also. A copy of letter dated 19th April, 2016 referred to above received from the Election Commission of India and also a copy of this office letter of even number dated 4th April, 2016 addressed to Election Commission of India are sent herewith for necessary action.

- 2. As already notified by the Chief Returning Officer, the date of Polling has been fixed for 10.05.2016. Accordingly, it is requested that prompt necessary action may be taken for procurement of Ballot Boxes from respective Chief Electoral Officers of States/Union Territories & their distribution to all the SSAs/Units under your control. Further, time schedule etc. for procurement and distribution of ballot boxes is indicated in the "Procedure for conducting membership verification...." already uploaded on intranet on 11th April.
- 3. Further, the table attached to this office letter dated 4th April, 2016 addressed to the Election Commission of India indicates that some Circles within a State have been clubbed. In order to ensure smooth procurement and distribution of ballot boxes, the following arrangement is suggested: -
 - NTR shall collect the ballot boxes on behalf of BSNL C.O. also and arrange its distribution.

- MP Circle shall collect the ballot boxes on behalf of BRBRAITT Jabalpur, T&D/Insp. Circle Jabalpur, TFs, Jabalpur & Richhai and arrange proper distribution.
- Maharashtra Circle shall collect the ballot boxes on behalf of TF Mumbai and arrange proper distribution.
- Chennai Telephone District shall collect the ballot boxes on behalf of Tamilnadu Telecom Circle also and arrange proper distribution.

➤ UP East Circle shall collect the ballot boxes on behalf of UP West Circle & ALTTC, Ghaziabad and arrange proper distribution.

➤ Kolkatta Telephone District shall collect the ballot boxes on behalf of WB Telecom Circle, Telecom Stores, Kolkatta & TF Kolkatta and arrange proper distribution.
