Subject: Option to change authorization for deduction of membership subscription from salary- - reg.

Sir,

I am directed to say that the existing guidelines on the above subject which allows employees to opt out (withdraw/stop) or change of authorization of membership subscription in favour of Union of their choice twice in a year i.e. in the month of June-July & Dec.-January have been reviewed in this office and it has been decided by the competent authority that

- a) The forthcoming process of change of option for membership subscription due from 16.12.2019 to 15.01.2020 may be skipped as a onetime measure.
- b) Now onwards the employees shall be allowed to change their option for authorization of deduction of membership subscription in favour of the Union of their choice, once in year during the period from 16th June to 15th July
- 2. The above instructions shall be applicable in case of membership subscription of Executives' Associations also.
