I am directed to state that a Special Recruitment Drive (SRD) for SC/ST/OBC
candidates for recruitment of Telecom Technical Assistant (TTA) (now re-designated
as Junior Engineer) in BSNL was conducted on 21/02/2016. The result of the
aforesaid SRD examination was declared vide this Office letter of even no. dated
10/03/2016 and the concerned circles were directed to issue offer of appointments
to the selected candidates.

2. Subsequently, vide this Office letter of even no. dated 15/07/2016, the
concerned circles were asked to intimate the status of joining/refusal of joining of the
selected candidates in the circle, so that the offer of appointment might be made to
the Wait Listed candidates in the order of their merit and available vacancies.

3. As per information received from the circles for filling up the resultant unfilled
vacancies, a second list of the provisionally selected candidates for appointment from
the Waiting List in the order of their merit of the said examination and choice of their
preferred Circle is enclosed at **Annexure-A**. Their online application forms are being
forwarded herewith for further necessary action at your end. These Online
application forms will form part of the dossier of the candidates.

4. The result has been prepared based on the merit position of the online
examination held on 21/02/2016 and choice of preferences of circles given by these
Wait Listed candidates as per the unfilled vacancies reported by the concerned
Circles.

5. The concerned Circles are, therefore, requested to issue offer of appointment to
the selected candidates for the post of Junior Engineer (formerly TTA) in BSNL. In
case of their refusal or found ineligible for the said post, the matter may be
immediately communicated to the Recruitment Branch, BSNL CO, so that the offer of
appointment may be given to the next Wait Listed candidates in the order of their
merit position.

7. The above action may commence immediately and all actions may be completed in a time bound manner as per the schedule given below :-

- i) Issue of letter to selected candidates for verification of documents and other formalities : 25/11/2016
- ii) Completion of verifications of documents, including Police verification and Medical Examination Certificate etc. : 31/12/2016
- iii) Sending the candidates for pre-recruitment training : 15/01/2017

8. All correspondence regarding any clarification with regard to document verification may be addressed to GM (Estt), BSNL CO and for training etc. to GM (Training), BSNL CO.

9. Extension of time to candidates may not be granted ordinarily. In exceptional cases, extension can be given upto 15 days by the Circle.


