Pursuant to the directions of the DoP&T vide its OM No. 36038/01/2013-Estt(Res.) dated 16.12.2014 with regard to the implementation of the recommendations of the Committee to analyze the reasons for less employability of SCs, STs, OBCs in Government Sector and its remedial measures, approval of the Competent Authority is hereby conveyed for holding of SRD for filling up the backlog vacancies of the Recruitment Year-2012 in TTA cadre through Direct Recruitment. The number of vacancies which may be filled up by conducting SRD are given hereunder against each Circle who have reported such vacancies:-

- 2. The said SRD shall be conducted in accordance with the provisions of the Recruitment Rules of TTA-2014 circulated vide letter No. 250-7/2013-Pers-III dated 25.08.2014. The Scheme and Syllabus for the SRD shall be as stipulated in letter No. 250-18/2008-Pers-III dated 4.9.2008. The qualifying marks in each of the three parts as mentioned in para (i) of letter No. 250-23/2008-Pers-III dated 29.10.2008 and the minimum aggregate marks in the paper as mentioned in letter No. 10-1/2008-Rectt. Dated 13.10.2008, which were prescribed for DR-TTA-2012 examination shall be applicable for SRD also. It may also be noted that the Waiting list of qualified candidates shall be governed as per the instructions issued vide letter No. 250-18/2006-Pers-III (part-2) dated 21.10.2008. However, the Waiting list shall remain valid for 6 months, as the process of SRD has to be completed in a time bound manner.
- 3. The concerned Heads of the Circles are requested to initiate the process of conducting examination for SRD for SCs, STs, & OBCs immediately and ensure that the remaining backlog reserved vacancies are filled up by 31.03.2016. Further instructions regarding process of holding of said examination shall be issued by Rectt. Branch of BSNL CO separately.
- 4. The deployment of the selected candidates in different SSAs/Units shall be done after taking into account the demands of the Non-recruiting Circles/Projects, Maintenance Regions etc. BSNL Corporate office may be kept informed about the status of the No. of candidates who join as TTA through SRD and a copy of the same may be endorsed to SCT Cell of BSNL CO.
