**Circular R&C-CFA No. 61/15-16**

**Subject: - Introduction of On-Net free Night Calling facility to Post-paid CDMA Fixed/Limited customers.**

Kindly refer this office circular on introduction of Free Night calling facility to Landline customers. Now Competent Authority has examined the CDMA post-paid fixed/limited tariff plans and decided that:

1. Unlimited free calls between **9 PM to 7 AM** on Landline & Mobile of BSNL Network (STD/Local) i.e. On-Net only shall be offered from postpaid CDMA fixed/limited connections.
2. Revised Monthly rental charges and free MCU issued vide letter No R&C-CFA No.03/15-16 dated 10-04-2015 shall be applicable on BSNL CDMA Fixed/limited postpaid customers.
3. ***Above tariff will be effective from 01-09-2015.***
4. This may be brought to the notice of all concerned for taking necessary action in this regard.
5. All Circles will take necessary action for popularization of above schemes.
6. Circles have to update their website and report the same to TRAI as per tariff reporting requirement of TRAI.
7. ***Circles shall ensure to comply with all regulatory mechanism.***
8. The Circular is issued based on the approval of Competent Authority in NWP-CDMA Cell File No. 69-03/2009-CDMA/Tariff/Vol.IV/Pt.Clarification/correspondence, if any, in respect of above tariff may be sent to NWP-CDMA/Wi-Max Section, BSNL, Corporate Office, Janpath, New Delhi-110001, Tel.
