In view of the acute shortage of staff quarters in Delhi, problems are being faced by the officers/officials who are working in BSNL in Delhi. Officers/officials already in occupation of staff quarters make request for retention of Quarters on their transfer, retirement etc. thus making it difficult for the waiting officers/officials to get residential accommodation in Delhi.

The case has been examined in BSNL Corporate Office and approval of competent authority is hereby conveyed to reduce the time period of retention of BSNL staff quarters under various categories in Delhi as under:-
