

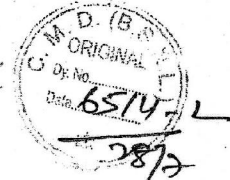

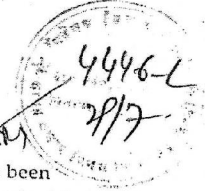

2. In reference of para '3' of your letter, it is submitted that there is no need of fresh approval to issuance of Presidential Order, if approval has already been conveyed by this Department. The Presidential Order of the officials i.e. mentioned at Sl. No. 4, 5, 6 & 7 of this office letter dated 06.11.2013 are issued by the Director (Estt.) nominated at the respective Telecom Circle.

3. However, before issue of Presidential order, it may be ensured that no vigilance case/disciplinary case pending/contemplated against the officials. It may also be checked that regularisation of the above-mentioned officials has been done in pursuance of letter No. 269-94/98-STN.II dated 29.09.2000. The POs of the above-mentioned officials may be issued in their substantive grade as on 30.09.2000 after due verification of their records. In other words, the PO should be issued on same terms and conditions as were applicable to similarly placed persons, after due verification of service rendered.
